

# Pfizer Declares 28-Cent Fourth-Quarter 2015 Dividend

The board of directors of Pfizer Inc. today declared a 28-cent fourth-quarter 2015 dividend on the company's common stock, payable December 1, 2015, to shareholders of record at the close of business on November 6, 2015.
