

## NH Citizens Health Initiative to Premiere Mini-Documentaries on NH Multi-Stakeholder Patient Centered Medical Home Pilot

They use processes and technology that ensure good health outcomes, and provide consumer conveniences such as same-day scheduling and secure e-mail communications. The patient-centered medical home strengthens the patient-physician relationship by allowing the doctor and team of health professionals to spend more time with each patient and to develop and follow through on an individualized plan of care. Medical homes have been shown to improve health outcomes, reduce costs and improve patient, family, physician and staff

satisfaction.

The two mini-documentaries stemmed from the NH Multi-Stakeholder Patient-Centered Medical Home Pilot, a project of the Citizens Health Initiative.
